MPCSD RELEASE OF INFORMATION

Release of Student and Parent Information

The Menlo Park City School District recognizes the importance of maintaining the confidentiality of student and parent information. Release of this information is only done in accordance with District policy, which adheres to federal and state law.

The District only releases information that is not generally considered harmful or an invasion of privacy if disclosed. By law, parents/guardians have the right to refuse the release of certain designated information by informing the District during online enrollment or on a change of release form. The MPCSD is an inclusive community with involved parent volunteers and student-centered activities which requires multiple communication platforms. Understanding your preference for sharing data will help us connect you to the appropriate resources. (Note: Social Security numbers are not collected by the District and the District never releases medical information.)

District Family Directory

The District provides an online, password-protected Student Family Directory available to district families. The directory includes parent name(s) and contact information (home address, phone number, parent email address) and your student's name, school, grade, and teacher. If you **do not** want your information included in the Student Family Directory, check the opt out box below.
